Marlin opened the meeting at 6:33 pm.

Mark moved, Marlin second, to approve the agenda with the addition of Superior Woodworks to Old Business and Brownfield Redevelopment Workshop and Invoice to New Business. Passed unanimously.

Marlin moved, Mark second, to approve the March 16, 2010, minutes. Passed unanimously.

## Old Business

John led the discussion on Mt. Horace Greeley. He received archive material from the County that he will review. Marlin presented copies of an email from the federal GSA, stating they are planning to sell their part of the property this summer at auction. Much discussion. Steven moved, Dave second, for Marlin to pursue acquisition of this federal property and inform the Keweenaw County Board of the Authority's action. Passed – six yes, one no. Bill stated that the Louisiana-Pacific representatives are interested in attending our dinner meeting. Dave stated that Allouez Township and the Village of Ahmeek are interested in the site as a transfer station.
