# Keweenaw County Brownfield Redevelopment Authority August 16, 2011

Marlin called the meeting to order at 6:32 p.m.

Dave moved, Marlin second, to approve the agenda as printed. Passed unanimously.

#### Old Business

### **EDC**

Dave reported that they are entering the 1<sup>st</sup> phase of a bio-fuel study funded by a grant from Keweenaw County to identify the availability of raw materials. Other possibilities that have been mentioned for Keweenaw County include a water park for younger children and greenhouses heated from bio fuel waste heat.

# Mt Horace Greeley

The phase II environmental site assessment (which is in draft form) was discussed.

Noted items include contamination identified at locations REC-6 and REC-7.

It was discussed that the DEQ may use the report to request that the Air Force further investigate and clean up portions of the site.

We discussed four different issues with the site and the scenarios of responsibility with each issue. The issues were Building and infrastructure/soil contamination/ground water contamination/potable water system

The phase II report will be available approximately August 23<sup>rd</sup> and will be sent to the DEQ.

A meeting will be set up with the DEQ once they have reviewed the report to evaluate their opinion.

We could possibly pursue a grant to demolish the buildings due to the lead paint.

### Louisiana-Pacific

Bill Griffin spoke with Brett Beaumier who manages the environmental issues on the property and provided Brett with a copy of the phase I report.

L-P denied the phase II request at this time due to the possibility of additional liability based on the results.

Bill Griffin is to draft a letter requesting that L-P transfer the property to the Brownfield Authority.

# Gay School

Sampling for the phase II assessment is completed but results are not available yet. Bill hopes to have the phase II report available for the next meeting.

#### Mohawk

Phase II drilling will take place on August 17<sup>th</sup>. Bill Griffin understands that thee still is an interested buyer. Bill provided the phase I report to the authority.
