GENERAL SPECIFICATIONS

- 1. THE ENTIRE BID DOCUMENT PACKAGE, INCLUDING THE NOTICE TO BID, SPECIFICATIONS, ANY ADDENDA AND THE BID PROPOSAL FORM SHALL BE SIGNED AND SUBMITTED TO THE KEWEENAW COUNTY ROAD COMMISSION. ANY INCOMPLETE BID PROPOSAL SHALL BE REJECTED.**
2. The Keweenaw County Board of Road Commissioners reserves the right to reject any or all bids, or to waive irregularities and to accept the proposal that in the opinion of the board is in the best interest and to the best advantage of the Board of County Road Commissioners of Keweenaw County, Michigan.
3. The Keweenaw County Board of Road Commissioners reserves the right to adjust quantities as it deems necessary. All bid quantities are approximate and are subject to change.
4. All items shall be bid as delivered to the Keweenaw County Road Commission, Mohawk, Michigan, unless specified otherwise in individual proposal specifications.
5. All equipment and/or vehicles shall conform to all applicable Federal, State and Local safety standards.
6. All bids shall be submitted in a sealed envelope, on Keweenaw County Road Commission bid sheets, and clearly marked as to the date of the opening and name of item being bid.
7. Bids shall remain valid for at least 30 days.
8. Bids for all purchases shall be stated on the basis of payment as net days after receipt of services or products, unless stated otherwise in individual specifications.
9. A Supplier of equipment or materials for purchase by Keweenaw County Board of Road Commissioners should carry Product Liability Insurance, where applicable, within reasonable limits for that product. The inclusion of a Certificate of Coverage with the bid proposal may be considered as preferable purchase over a bid proposal which is submitted without such certificate

WINTER SAND HAUL SPECIFICATIONS

1. All material will be furnished by the Keweenaw County Road Commission from pit in Gay. All material shall be loaded and hauled by the Contractor from the Gay Stamp Sands, to the KCRC shop facility in Mohawk.
2. Piling of sand will be performed by the Keweenaw County Road Commission, unless modified by Bid Item #2, (if item awarded).
3. The basis of pay will be by the ton. Contractor shall have front end loader with scale bucket and provide daily load tickets and daily truck load counts for review and verification by Keweenaw County Road Commission.
4. Load counts will be used to determine minimum haul requirement per day only.
5. Individual delivery slips will be dropped at the garage/shop for each trip by each truck.
6. All material is to be delivered during the period of September 15th to October 10th, 2025 (*4 weeks*).
7. The Contractor shall slope all pit faces used by themselves, when completed, to a 1 vertical to 3 horizontal slope.
8. A minimum of 500 tons per day must be hauled each day unless by mutual agreement with the Road Commission.
9. No hauling will be permitted on Friday, Saturday or Sunday, unless overtime premium of \$1,000.00 per 8-hour day is paid for by the Contractor and only if a Road Commission employee is available for stockpiling.
